- d) Deadline for submission of fees fees must be received or supporting paperwork (PO/check request) before the students can audition on the audition date (request your checks early!)
- e) Enter all directors assistants, middle school directors, etc. Make sure that the head director of the school entering is the one entering students.
- f) Check spelling and capitalization carefully while entering students this data is transferred to programs, archives and given to colleges requesting it for scholarship considerations.
- g) There will be no late entries or corrections after the entry deadline.
- 10) No known errata other than that printed in PAL online.
 - a) Duties of directors at clinic/concert.
 - b) Area fees \$25 will be paid by the region if over 475 entries
 - c) Be aware of holding room guidelines at Area: (https://www.atssb.org/files/execsec/HoldingRoomGuidelines.pdf)
 - d) Be aware of housing procedures at all-state (Hyatt Regency) and that students must bring a wire stand to state.
 - e) Note that at All-State Chair auditions, no electronic devices shall be allowed in the audition room other than tuners and metronomes (no cell phones or mp3 players or iPods if found, these will be taken up until after auditions); however, students may use electronic media in lieu of printed music (a book is still provided on the stand for student use) so long as the media does not conflict with existing rules governing electronic devices as listed above.
 - f) OPS entry deadline (see OPS guidelines online or March Newsletter OPS Column).

11) Rules

- a) Eligibility home school students are not eligible to audition through ATSSB must go through TMEA or TPSMEA
- b) Instrumentation for each band is posted on region websit
 - i) students selected to advance to Area but do not make the region cut will be accepted into the region band up to 50% of the number of students in the bands
 - ii) Euphonium changes 4 advance from region to area; 1 advances from area state; 3 from recordings made after area will advance to state from all 5 areas; both 3A and 4A tracks
- c) Judging requirements if entering students. Directors entering students must make themselves available to adjudicate entries. Ratio of 1 judge for every 10 entries
- d) Rules are posted online
- e) Reminder that that no pictures may be taken, nor any audio or video recordings made in the room(s) where judges' scores are displayed for directors to check. This may be online this year
- f) Remind them that in jazz auditions when recordings are made for advancing to Area, pause between each section and only use the script to be read by the recording monitor or engineer stating the instrument, the student's name, and school at the end of each recording; also, to use the recording available online for each region and area jazz that has the accompaniment tracks only to minimize disqualifications.
- 12) State Officer Nominations (Class 2C/3C, 2A and 4A Representatives to the State Board this year does not need to be from our region)
